3 **WHEREAS**, Florenzo P. Fejeran, also known as Larry, Chief, Ref, Pare,
4 and Primo began his career with the Public Defender Service Corporation (PDSC)
5 in September 1976 as a General Helper; and

6 **WHEREAS**, throughout his thirty-six (36) years with the PDSC Larry has
7 excelled through the ranks holding a total of twelve (12) different positions,
8 beginning as a General Helper working his way up to becoming the Chief
9 Investigator in 1994; and

10 **WHEREAS**, by keeping an open-mind toward his colleagues as well as his
11 professional encounters, Larry developed his people skills allowing him to succeed
12 in life; and

13 **WHEREAS**, knowing early on that an education beyond high-school would
14 further develop his career and personal well being, Larry attended the University of

1 Guam as a Regent Scholar and graduated in 1988 with a Bachelors degree in
2 Criminal Justice; and

3 **WHEREAS**, Larry is a firm believer in the self-education attitude to
4 develop one's career; and that learning the roles and responsibilities of the whole
5 work environment makes for better leadership; and

6 **WHEREAS**, six (6) years following his graduation from the University of
7 Guam, Larry became the Chief Investigator and successfully held that position
8 with honor and performance beyond expectations, without incident or adverse
9 action; and

10 **WHEREAS**, as Chief Investigator, Larry lead the Investigation section with
11 dignity and equal respect toward his subordinates, always lending an ear or a
12 helping hand through the tough times; and

13 **WHEREAS**, while serving as Chief Investigator, Larry excelled as a liaison
14 between the Public Defender and other government agencies as well as private
15 parties, in obtaining information pertinent toward the goals and objectives of case
16 investigations; and

17 **WHEREAS**, Larry's work experiences gave him the ability to understand
18 and evaluate issues and circumstances that naturally transpire in the work
19 environment, allowing him to resolve conflicts or issues so that the mission of the
20 Public Defender Service Corporation continues to move forward; now, therefore be
