10	WHEREAS, the Port continues to support the neighboring islands of Micronesia,
11	transshipping approximately twenty nine million (29,000,000) gallons of fuel and five hundred
12	thousand (500,000) revenue tons of essential goods throughout Micronesia; and
13	WHEREAS, three hundred seventy four (374) employees operate and maintain five (5)
14	cargo handling piers, a container yard, two (2) marinas and a harbor of refuge; and
