RELATIVE TO CONGRATULATING THE EMPLOYEES, MANAGEMENT AND THE BOARD OF DIRECTORS OF *THE JOSE D. LEON GUERRERO COMMERCIAL PORT* AS THEY CELEBRATE THEIR THIRTY-SEVENTH (37th) ANNIVERSARY AND OBSERVE OCTOBER 15-19, 2012, AS PORT WEEK.

BE IT RESOLVED BY *I MINA' TRENTAI UNU NA LIHESLATURAN GUÅHAN*:

WHEREAS, the Jose D. Leon Guerrero Commercial Port ("Port") was established as a public corporation and autonomous government agency by Public Law 13-87 in October 1975; and

WHEREAS, over the last three decades, the Port has developed into a major transshipment center for the Western Pacific Region providing full services to ocean passenger, cargo and fishing vessels; and

WHEREAS, in fiscal year 2012, the Port processed more than one million one hundred thousand (1,100,000) revenue tons of cargo, providing vital goods to Guam; and

WHEREAS, the Port continues to support the neighboring islands of Micronesia, transshipping approximately twenty nine million (29,000,000) gallons of fuel and five hundred thousand (500,000) revenue tons of essential goods throughout Micronesia; and

WHEREAS, three hundred seventy four (374) employees operate and maintain five (5) cargo handling piers, a container yard, two (2) marinas and a harbor of refuge; and

WHEREAS, the Board of Directors, Management and employees remain committed and steadfast in taking on the enormous challenge of modernizing the port in anticipation of the island's organic growth; now therefore be it

RESOLVED, that *I Mina' Trentai Unu Na Liheslaturan Guåhan* does hereby on behalf of the people of Guam, congratulate and commend the dedicated employees and management of
