WHEREAS, Dr. Jose Capistrano Cariaga was born on January 11, 1927 and
passed away on April 15, 2011; and

WHEREAS, Dr. Jose Capistrano Cariaga was educated and graduated from
the University of Santo Tomas in the Philippines in 1952; and

WHEREAS, he completed his internship at Callidonean Hospital in
Brooklyn, New York in 1953 and his rotating internship from 1955 until 1958 at
the St. Francis Hospital in New York. Dr. Jose Capistrano Cariaga also completed
his specialty training in Internal Medicine in 1959 at Highland Hospital in
Rochester, New York and in Psychiatry from State Hospital, New York; and

WHEREAS, Dr. Jose Capistrano Cariaga dedicated over thirty (30) years of
his life to serving the community of Guam from 1970 until 2002. He worked at the

1 Catholic Medical Center, Family Health Plan and Public Health during his time on
2 island; and
