San Nicolas, Mayor of Asan-Maina, for twenty-four (24) years of exemplary service, contribution and support to the people of Asan-Maina, to the Mayors' Council of Guam, and the people of Guam.

1        **BE IT RESOLVED BY *I MINA' TRENTAI UNU NA LIHESLATURAN***  
2        ***GUÅHAN*:**

3        **WHEREAS**, the Honorable Mayor Vicente "Benny" L. San Nicolas was  
4        elected Mayor of the Municipality of Asan-Maina in 1988, and upon taking his  
5        Oath of Office on January 09, 1989, Mayor San Nicolas began serving the people  
6        of Asan-Maina; and

7        **WHEREAS**, during his tenure in office Mayor Vicente "Benny" L. San  
8        Nicolas served the people of Asan-Maina and the people of Guam in a most  
9        honorable and exemplary manner always ensuring that the health, safety and  
10       general wellbeing of the residents of Asan-Maina were attended to; and

11       **WHEREAS**, during his tenure in office, Mayor Vicente "Benny" L. San  
12       Nicolas also served as an officer for the Mayors' Council of Guam holding the  
13       position of Sergeant-At-Arms in 1991; and

14       **WHEREAS**, in addition to performing his duties and responsibilities as  
15       Mayor of Asan-Maina, the Honorable Vicente "Benny" L. San Nicolas served as a

1 Member of the Reverend, Dr. Martin Luther King, Jr. Human and Civil Rights  
2 Commission; Member of the Civilian/Military Task Force; and Member of the  
3 Association of Mariana Islands Mayors Vice Mayors and Elected Municipal  
4 Council Members (AMIM);

5 **WHEREAS**, Mayor Vicente “Benny” L. San Nicolas’ membership in the  
6 Mayors’ Council of Guam will expire on January 7, 2013 concurrently with his  
7 term as Mayor of the Municipality of Asan-Maina having served a total of six (6)  
8 terms in office; and now, therefore be it

9 **RESOLVED**, that *I Mina’ Trentai Unu Na Liheslaturan Guåhan* does  
10 hereby, on behalf of the people of Guam, extends an *Un Dangko’lo Na Si Yu’os*  
11 *Ma’åse* to the Honorable Vicente “Benny” L. San Nicolas, Mayor of Asan-Maina,  
12 for twenty-four (24) years of exemplary service, contribution and support to the  
13 people of Asan-Maina, to the Mayors’ Council of Guam, and the people of Guam  
14 as a whole; and be it further

15 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest  
16 to, the adoption hereof, and that copies of the same be thereafter transmitted to the  
17 Honorable Vicente “Benny” L. San Nicolas, Mayor of Asan-Maina; to the Mayors’  
18 Council of Guam; and to the Honorable Edward B. Calvo, *I Maga’låhen Guåhan*.
