Relative to the budgetary allocations of *I Mina'Trentai Dos Na Liheslaturan Guåhan*, the 32nd Guam Legislature, for Fiscal Year 2013.

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF**
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, the Committee on Rules has oversight of the business, budget,
4 design and activities of *I Liheslaturan Guåhan* (the Guam Legislature), is constituted
5 as the policy-making body of *I Liheslaturan Guåhan*, and shall prescribe all policies
6 governing the administration and operations of the budget of *I Liheslaturan Guåhan*,
7 including, staff organization, function, personnel requirements and rates of
8 compensation; and

9 **WHEREAS**, the Fiscal Year 2013 Appropriations Act, P.L. 31-233, included
10 an appropriation to the Guam Legislature for Seven Million Sixty-Three Thousand
11 One Hundred Thirty-Three Dollars (\$7,063,133.00) for the period of October 1, 2012
12 to September 30, 2013; and

1 **WHEREAS**, the amount of One Million Seven Hundred Sixty-Five Thousand
2 Seven Hundred Eighty-Three Dollars and Twenty-Five Cents (\$1,765,783.25) was
3 allocated for the first (1st) quarter of Fiscal Year 2013 (FY13), leaving a balance of
4 Five Million Two Hundred Ninety-Seven Thousand Three Hundred Forty-Nine
5 Dollars and Seventy-Five Cents (\$5,297,349.75); and

6 **WHEREAS**, *I Liheslaturan Guåhan* has recognized its fiscal responsibilities
7 and has taken into consideration the current economic and fiscal restraints of the
8 government of Guam in preparing its FY 2013 budget. In doing so, it is the intent of *I*
9 *Mina'Trentai Dos Na Liheslaturan Guåhan* to expend lapsed funds of the outgoing
10 Senatorial Offices of *I Mina'Trentai Unu Na Liheslaturan Guåhan* to cover any
11 budgetary shortfalls; now therefore, be it

12 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
13 *Liheslaturan Guåhan* does hereby adopt as its budget request for the remaining nine
14 (9) months of FY 13, the sum of Five Million Two Hundred Ninety-Seven Thousand
15 Three Hundred Forty-Nine Dollars and Seventy-Five Cents (\$5,297,349.75); and be it
16 further

17 **RESOLVED**, that based on this budget request, the following allocations each
18 reflect a further reduction of five percent (5%), equivalent to the following reductions:
19 from the Office of the Speaker - Eighteen Thousand Three Hundred Fifty-Two Dollars
20 (\$18,352); from the Majority Senatorial Offices/Standing Committees - One Hundred
21 Twenty-Two Thousand Three Hundred Eighty Dollars (\$122,380); from the Minority
22 Senatorial Offices/Operations - Fifty-One Thousand Three Hundred Six Dollars
23 (\$51,306); and from Central Operations - One Hundred Ninety-One Thousand Four
24 Hundred Sixty-Four Dollars (\$191,464). The following allocations *shall* also be
25 adopted, in accordance with the Standing Rules, as the adopted budget for *I*
26 *Mina'Trentai Dos Na Liheslaturan Guåhan* for the remaining nine (9) months of FY

1 13, subject to the availability of funds, subject to further modification and amendment
2 to this adopted budget by the Committee on Rules, and subject to transfer, by the
3 Chairperson of the Committee on Rules, within any various accounts of *I Liheslaturan*
4 *Guåhan* in order to ensure smooth operations:

5 Office of the Speaker \$261,516;

6 Majority Senatorial Offices/Standing Committees \$1,743,879;

7 Minority Senatorial Offices/Operations \$731,070;

8 Central Operations \$2,560,884.75; and be it further

9 **RESOLVED**, that the Chairperson of the Committee on Rules is further
10 authorized to withhold a portion of the amount allocated to the Office of the Speaker,
11 and to any Majority Senatorial Office/Standing Committee and/or Minority Senatorial
12 Office/Operations, in order to recover any monies equal to the outstanding balance
13 owed to the Central Operations Fund of *I Liheslaturan Guåhan*, and to economize and
14 utilize all funding sources under the exclusive control and purview of *I Liheslaturan*
15 *Guåhan* to address prior obligations; and be it further

16 **RESOLVED**, that each of the aforementioned budget allocations, namely, the
17 Office of the Speaker, the Majority Senatorial Offices/Standing Committees, the
18 Minority Senatorial Offices/Operations, and Central Operations, *shall* be effective
19 January 7, 2013; and be it further


20 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
21 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
22 the same be thereafter transmitted to the Members of the Committee on Rules of *I*
23 *Mina'Trentai Dos Na Liheslaturan Guåhan*; to the Honorable Judith T. Won Pat,
24 Ed.D., Speaker of *I Mina'Trentai Dos Na Liheslaturan Guåhan*; to the Honorable
25 Benjamin J.F. Cruz, Vice-Speaker of *I Mina'Trentai Dos Na Liheslaturan Guåhan*; to

- 1 all other Members of *I Mina'Trentai Dos Na Liheslaturan Guåhan*; and to Vincent P.
- 2 Arriola, Executive Director of the Guam Legislature.
