1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***
3 **WHEREAS**, the late Honorable Mayor Dean D. Sanchez was born on June 21,
4 1961, and was called to his eternal reward on Monday, January 14, 2013, at the age of
5 fifty-one (51) years; and

1 **WHEREAS**, the late Honorable Mayor Dean D. Sanchez is the son of Former
2 Chief Commissioner †Vicente Q. Sanchez and Priscilla Q. Sanchez; and his siblings,
3 they are, namely: Reina, Jacques and Zita Quintanilla Sanchez, Clair, and Erskin and
4 Judy Diaz Sanchez; and

5 **WHEREAS**, the late Honorable Mayor Dean D. Sanchez married Jennifer
6 Aguon Sanchez, and they have two (2) sons: Alexander Dean and Chance Theo; and

7 **WHEREAS**, prior to serving the people of *Umatac* as Mayor, the late
8 Honorable Dean D. Sanchez was employed as the Administrative Assistant from
9 January 9, 1989, to July 5, 1991. during the term of the late Former Mayor Albert T.
10 Topasna; and

11 **WHEREAS**, upon the untimely passing of the late Honorable Albert T.
12 Topasna, the late Honorable Dean D. Sanchez was appointed by the Honorable Joseph
13 F. Ada, Governor of Guam to serve as Mayor for the Municipality of *Umatac*; and

14 **WHEREAS**, following his appointment as Mayor from July 5, 1991, to
15 January 4, 1993, the late Mayor Sanchez returned to serve the people of *Umatac* as the
16 Administrative Assistant for then Mayor Daniel Q. Sanchez; and

17 **WHEREAS**, in 2008, the late Honorable Mayor Dean D. Sanchez was elected
18 Mayor for the Municipality of *Umatac*, and upon taking his Oath of Office on January
19 5, 2009, Mayor Sanchez began serving the people of *Umatac*; and

20 **WHEREAS**, during his tenure in office, the late Mayor Sanchez served the
21 people of *Umatac* and the people of Guam in a most honorable and exemplary
22 manner, ensuring that the health, safety and general wellbeing of the residents of
23 *Umatac* were attended to; and

24 **WHEREAS**, during his tenure in office, and in addition to his duties and
25 responsibilities as Mayor of *Umatac*, the late Honorable Dean D. Sanchez served as a
26 Member of the Commission on Self Determination; Member of the Guam Product

1 Seal Task Force; Member of the Department of Agriculture Aquatic & Wildlife
2 Resources - Fisheries; Member of the Civilian/Military Task Force; and Member of
3 the Association of Mariana Islands Mayors (AMIM), Vice Mayors, and Elected
4 Municipal Council Members; now therefore, be it


5 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*

14 *Maga'låhen Guåhan*.


