1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, the Honorable Adolpho Borja Palacios, Sr., is a longtime resident
4 of Guam, and he has served our island community in various capacities; and

5 **WHEREAS**, in 1969, the Honorable Adolpho Borja Palacios, Sr., entered
6 public service working at the Guam Police Department, where he bravely served until
7 his retirement in 1989 at the rank of Captain; and

1 **WHEREAS**, following his retirement from the Guam Police Department, the
2 Honorable Adolpho Borja Palacios, Sr., served as Chief Marshal of the Superior Court
3 of Guam from 1989 to 1991; and

4 **WHEREAS**, in 2004, the Honorable Adolpho Borja Palacios, Sr., was elected
5 by the people of Guam to serve his first (1st) term as a Member of *I Mina'Bente Ocho*
6 *Na Liheslaturan Guåhan* (the 28th Guam Legislature). He was re-elected in 2006,
7 2008 and 2010 to continue his service as a Senator of Guam, and he most recently
8 served as the Chairman of the Committee on Public Safety, Law Enforcement and
9 Judiciary of *I Mina'Trentai Unu Na Liheslaturan Guåhan* (the 31st Guam
10 Legislature); and

11 **WHEREAS**, in his role as a public servant, Senator Palacios remained
12 committed to supporting individuals in the community who required assistance for
13 medical treatment, and helping individuals who felt hopeless when dealing with
14 unresponsive sectors of our government; and

15 **WHEREAS**, as a Member of *I Liheslaturan Guåhan*, Senator Palacios was a
16 tireless advocate for reforming and increasing transparency at our public safety
17 agencies within the government of Guam so that those instrumentalities could more
18 effectively serve our community; now therefore, be it

19 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
20 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
21 of Guam, recognize and commend the Honorable Adolpho Borja Palacios, Sr., for his
22 service to the people of Guam as a Member of *I Liheslaturan Guåhan*; and be it
23 further

24 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
25 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of

- 1 the same be thereafter transmitted to the Honorable Adolpho B. Palacios, Sr.; and to
