1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, the Honorable Judith Paulette Guthertz, DPA, is a longtime
4 resident of Guam, and she has served our island community in various
5 capacities; and

1 **WHEREAS**, the Honorable Judith Paulette Guthertz, DPA, served as a
2 tenured professor with the University of Guam (UOG) School of Business and
3 Public Administration for approximately twenty-eight (28) years; and

4 **WHEREAS**, the Honorable Judith Paulette Guthertz, DPA, is a former
5 Chairperson of the UOG Department of Public Administration and Legal
6 Studies; and she has held the positions of Acting President and Vice President
7 of Academic Affairs at the University of Guam; and

8 **WHEREAS**, the Honorable Judith Paulette Guthertz, DPA, had served
9 as the Director of the former Guam Department of Public Safety; and she was
10 appointed to serve as the Chief of Police of the Guam Police Department; and

11 **WHEREAS**, in 2006, the Honorable Judith Paulette Guthertz, DPA, was
12 elected by the people of Guam to serve as a Member of *I Mina' Bente Nuebi Na*
13 *Liheslaturan Guåhan* (the 29th Guam Legislature). She was re-elected in 2008 to
14 serve as a Member of *I Mina'Trenta Na Liheslaturan Guåhan* (the 30th Guam
15 Legislature); and was re-elected again in 2010 as a Member of *I Mina'Trentai*
16 *Unu Na Liheslaturan Guåhan* (the 31st Guam Legislature), where she served as
17 the Chairperson of the Committee on the Military Buildup and Homeland
18 Security; and

19 **WHEREAS**, in her role as a public servant, Senator Guthertz remained
20 committed to providing legislative support to help maintain and improve
21 Guam's educational facilities; and she was a leading community voice for a
22 military buildup that would be mutually beneficial for Guam and the United
23 States of America; and


24 **WHEREAS**, as a Member of *I Liheslaturan Guåhan*, Senator Guthertz was
25 a vocal advocate for the reform of Guam's election laws, authoring public

1 laws which sought greater transparency of the electoral process and allowed
2 for greater participation in the voter initiative process; now therefore, be it


3 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
4 *Lihsaturan Guåhan* does hereby, on behalf of *I Lihsaturan Guåhan* and the
5 people of Guam, recognize and commend the Honorable Judith Paulette
6 Guthertz, DPA, for her service to the people of Guam as a Member of *I*
7 *Lihsaturan Guåhan*; and be it further

8 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
9 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
10 the same be thereafter transmitted to the Honorable Judith Paulette Guthertz, DPA;
11 and to the Honorable Edward J.B. Calvo, *I Maga'lahen Guåhan*.


