1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, the Honorable Frank Flores Blas, Jr., is a lifelong resident of
4 Guam, and he has served our island community in various capacities; and

5 **WHEREAS**, the Honorable Frank Flores Blas, Jr., served in the Guam Police
6 Department from 1983 to 1996, holding several positions, including Patrol Officer,
7 Criminal Investigations Agent, and Special Investigations Operations Sergeant; and

1 **WHEREAS**, in 2003, the Honorable Frank Flores Blas, Jr., was chosen as a
2 Cabinet Member for *I Maga'lahaen Guåhan*, serving as Guam's first Homeland
3 Security Advisor until 2006; and

4 **WHEREAS**, in 2006, the Honorable Frank Flores Blas, Jr., was elected by the
5 people of Guam to serve as a Member of *I Mina'Bente Nuebi Na Liheslaturan*
6 *Guåhan* (the 29th Guam Legislature); and he served as the Chairman of the Committee
7 on Health, Human Services and Homeland Security. He was re-elected in 2008 to
8 serve as a Member of *I Mina'Trenta Na Liheslaturan Guåhan* (the 30th Guam
9 Legislature); and he was re-elected again in 2010 as a Member of *I Mina'Trentai Unu*
10 *Na Liheslaturan Guåhan* (the 31st Guam Legislature), where he served as the Minority
11 Leader; and

12 **WHEREAS**, in his role as a public servant, Senator Blas became a leading
13 community voice in requesting that the federal government resolve the issue of war
14 reparations due to Guam for the survivors and their families of atrocities committed
15 during the Japanese occupation of Guam in World War II; and

16 **WHEREAS**, as a Member of *I Liheslaturan Guåhan*, Senator Blas was a
17 tireless advocate in pressing the federal government for the recovery of Compact
18 Impact reimbursements to our island, which would amount to millions of dollars
19 going to the infrastructural and economic improvement of Guam; now therefore, be it

20 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
21 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
22 of Guam, recognize and commend the Honorable Frank Flores Blas, Jr., for his
23 service to the people of Guam as a Member of *I Liheslaturan Guåhan*; and be it
24 further


25 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules

- 2 Honorable Edward J.B. Calvo, *I Maga'lahaen Guåhan*.


