1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, the Honorable Shirley “Sam” Mabini, Ph.D., is a lifelong resident
4 of Guam, and she has served our island community in various capacities; and

5 **WHEREAS**, the Honorable Shirley “Sam” Mabini, Ph.D., served as an
6 instructor at both the International Business College and the Guam Community
7 College; and

1 **WHEREAS**, in 2004, the Honorable Shirley “Sam” Mabini, Ph.D., was named
2 as an Associate Dean of the Guam Community College School of Technology and
3 Student Services, a position which she held until 2006; and

4 **WHEREAS**, the Honorable Shirley “Sam” Mabini, Ph.D., served as a Cabinet
5 Member for *I Maga’lahen Guåhan*, first as the Acting Director of the Guam Public
6 Library System in 2007, and then as the General Manager of PBS Guam from 2008 to
7 2010; and

8 **WHEREAS**, in 2010, the Honorable Shirley “Sam” Mabini, Ph.D., was elected
9 by the people of Guam to serve as a Member of *I Mina’Trentai Unu Na Liheslaturan*
10 *Guåhan*; and

11 **WHEREAS**, in her role as a public servant, Senator Mabini was a leading
12 voice for the integration of career and technical education as part of the Department of
13 Education curriculum, with the goal of helping prepare Guam’s students for life after
14 school: and

15 **WHEREAS**, as a Member of *I Liheslaturan Guåhan*, Senator Mabini remained
16 a vocal advocate for a strong and expanding workforce on Guam by authoring a public
17 law which mandated skills assessment testing as a requirement for government of
18 Guam employment; and another public law which required the use of local businesses
19 for training services as a condition of eligibility for the issuance of a Qualifying
20 Certificate; now therefore, be it

21 **RESOLVED**, that the Committee on Rules of *I Mina’Trentai Dos Na*
22 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
23 of Guam, recognize and commend the Honorable Shirley “Sam” Mabini, Ph.D., for
24 her service to the people of Guam as a Member of *I Liheslaturan Guåhan*; and be it
25 further

1 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
2 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
