3 **WHEREAS, Fire Captain Nick Perez, Firefighter EMR Tedrick B. Borja,**
4 **Firefighter EMT Andrew D. Babas, Firefighter EMR John Paul C. Taimanglo, and**

1 Firefighter Paramedic Gregory D. Simon are assigned to Station 2, U.S. Naval Base
2 Guam Fire and Emergency Services; and

3 **WHEREAS**, on December 24, 2012, the parents of thirteen (13) month old
4 Cameryn Nangauta brought the child to Station 2 at the U.S. Naval Magazine in *Santa*
5 *Rita* after she had been choking on a piece of food at their nearby home; and

6 **WHEREAS**, upon arrival at Station 2, Cameryn was unconscious and
7 unresponsive, and suffered from acute cyanosis due to a lack of oxygen; and

8 **WHEREAS**, Fire Captain Nick Perez, Firefighter EMR Tedrick B. Borja,
9 Firefighter EMT Andrew D. Babas, Firefighter EMR John Paul C. Taimanglo, and
10 Firefighter Paramedic Gregory D. Simon, reacting quickly and competently to the
11 situation, performed approximately ten (10) back blows on Cameryn, enabling them to
12 dislodge the airway obstruction and deliver oxygen to the child, effectively
13 resuscitating her and allowing her condition to improve; and

14 **WHEREAS**, the fact that Cameryn Nangauta is alive and well today is directly
15 attributable to the life-saving actions of these five (5) firefighters; and

16 **WHEREAS**, it is clear to *I Liheslaturan Guåhan* that the people of Guam are
17 well-served by these fine heroes; now therefore, be it

18 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
19 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people

13 Edward J.B. Calvo, *I Maga'lahaen Guåhan*.


