3           **WHEREAS**, Mr. Isidro Tinoso is an employee of the Outrigger Guam Resort,  
4 and was ending his shift on the night of February 12, 2013; and

5           **WHEREAS**, Mr. Isidro Tinoso heard the cries and commotion of the people  
6 entering the hotel, and he immediately went to see what was wrong; and

7           **WHEREAS**, Mr. Isidro Tinoso, with no regard for his personal safety, bravely  
8 rose to the defense of strangers; and

2 composure which allowed him to prevent further bloodshed; and

5           **WHEREAS**, Mr. Isidro Tinoso exemplifies everything that is good about  
6 Guam and its people, and Mr. Tinoso further exemplifies the endearing and inherent  
7 respect that the people of Guam have for their fellow man; and

8           **WHEREAS**, *I Mina'Trentai Dos Na Liheslaturan Guåhan* wishes to convey its  
9 sincerest gratitude to Mr. Isidro Tinoso, a true son of Guam, for his selfless bravery on  
10 behalf of the people of Guam; now therefore, be it

11           **RESOLVED**, that *I Mina'Trentai Dos Na Liheslaturan Guåhan* does hereby,  
12 on behalf of the people of Guam, recognize and commend Mr. Isidro Tinoso for his  
13 unyielding bravery in the face of danger, which allowed him to selflessly come to the  
14 defense and aid of those in danger; does praise Mr. Isidro Tinoso for his immense  
15 humility, even though he rightfully deserves the title of “hero” for his actions on that  
16 night; and does further extend *Un Dângkolo Na Si Yu'os Ma'åse* to Mr. Isidro Tinoso
