2 ***MINA'TRENTAI DOSNA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** Pacific Xtreme Combat “PXC,” a Guam-based Mixed
4 Martial Arts (MMA) promotion company, was established on Guam in 2004
5 and it has grown to be one of Guam’s premiere sporting events, showcasing

6 the highest level of organized mixed martial arts in the Asia-Pacific region,
7 attracting world class fighters to Guam, and facilitating the growth of local
8 mixed martial arts; and

9 **WHEREAS**, Pacific Xtreme Combat “PXC” partnered with Philippines
10 media giant TV5 to produce Professional Mixed Martial Arts competitions,
11 and exported its events to the Philippines, with a growing viewership
12 averaging over 750,000 viewers with 8 events from 2011 through 2013, making
13 PXC one of the top rated professional sports in Asia; and

14 **WHEREAS**, Pacific Xtreme Combat “PXC” has organized over 36
15 professional events and over 25 amateur events on Guam, and 8 events in the
16 Philippines, which is inclusive of live telecasts, as well as international on-line
17 streaming to thousands of fans from the United States, Japan, South Korea, the
18 Philippines, and abroad; and

19 **WHEREAS**, Pacific Xtreme Combat “PXC” is an outstanding
20 community partner, playing an active role in anti-violence and bullying
21 prevention with the “Keep it in the Cage” campaign; raising funds for
22 deployed National Guardsmen and women with the “For Our Troops”
23 broadcast telethon; and assisting our neighboring country of Japan with
24 recovery efforts after the earthquake and tsunami with the “Rise for Japan”
25 event; and

26 **WHEREAS**, Pacific Xtreme Combat “PXC” has provided increased
27 opportunities for our island residents, to include international recognition and
28 professional sports contracts with nationally sponsored sporting events, such
29 as the Ultimate Fighting Championship (UFC); and

30 **WHEREAS**, *I Mina'Trentai Dos Na Liheslaturan Guåhan* further desires to
31 acknowledge Pacific Xtreme Combat "PXC" and its partners and sponsors;
32 now therefore, be it

33 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
34 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
35 people of Guam, commend and congratulate Pacific Xtreme Combat "PXC"
36 on being one of Guam's premiere sporting events, and Guam's largest
37 exported sporting event; and does further extend *Un Dângkolo Na Si Yu'os*
38 *Ma'ásé* to Pacific Xtreme Combat "PXC" for its numerous contributions to our
39 community, and reaffirm our gratitude for its continued and steadfast
40 commitment to the people of Guam; and be it further

44 Honorable Edward J.B. Calvo, *I Maga'låhen Guåhan*.


