3 **WHEREAS**, Senior Master Sergeant Frank J. Leon Guerrero was born in 1954
4 in *Tamuning*; and

5 **WHEREAS**, after graduating from John F. Kennedy High School in 1972,
6 Sergeant Leon Guerrero attended the Cannons International Business College of
7 Hawaii, where he graduated in 1974 with a Diploma in Business Accounting; and

1 **WHEREAS**, from 1974 to 1989, Sergeant Leon Guerrero was employed by the
2 A.H Corporation as a Business and Operations Manager for its wholesale, retail and
3 service operations; and

4 **WHEREAS**, in May 1987, Sergeant Leon Guerrero enlisted in the Guam Air
5 National Guard as a traditional Guardsman. He was assigned to the 254th Civil
6 Engineering Squadron (CES) and the Base Emergency Engineering Force (PRIME
7 BEEF) team, where he served as a Liquid Fuels Maintenance Specialist; and he
8 received the Distinguished Honor Graduate Award of the Inventory Management
9 Specialist Course at Lowry Air Force Base in Colorado; and

10 **WHEREAS**, in May 1989, Sergeant Guerrero started his Active Guard Reserve
11 (AGR) tour with the 254CES PRIME BEEF team, and retrained as an Inventory
12 Management Specialist; and

13 **WHEREAS**, while assigned to the 254CES, Sergeant Leon Guerrero was the
14 Non Commissioned Officer In Charge for Mobility Supply and Material Control, and
15 he received the Pacific Air Force (PACAF) IG Outstanding Performer Award during
16 the Unit Compliance Inspection (UCI) in 1992. He also monitored the Air Force
17 Specialty Code (AFSC) and Readiness Training programs for the Squadron; and

18 **WHEREAS**, from May 1994 to April 2002, Sergeant Leon Guerrero was
19 assigned to the 254th Services Flight as the Readiness in Base Services (PRIME RIBS)
20 Manager for the Flight. He managed the AFSC and Readiness Training programs for
21 the PRIME RIBS team with 54 assigned members; and

22 **WHEREAS**, Sergeant Leon Guerrero was a major contributor to the Flights 2X
23 Outstanding rating during the December 2003 and May 2007 Unit Compliance
24 Inspection; and

25 **WHEREAS**, Sergeant Leon Guerrero is a recipient of several major awards
26 and decorations, including: the Meritorious Service Medal; the Air Force

1 Commendation Medal; the Air Force Achievement Medal; the Joint Meritorious Unit
2 Award; the Air Force Outstanding Unit Award; the Air Reserve Forces Meritorious
3 Service Medal; the National Defense Service Medal; the Global War on Terrorism
4 Service Medal; the Humanitarian Service Medal; the Air Force Longevity Service
5 Medal; and the Armed Forces Reserve Medal; now therefore, be it


6 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
