3 **WHEREAS, Mr. David Leon Guerrero Taitague, fondly known as “Uncle**
4 **Dave,” was born and raised on Guam. He was born on December 29, 1949, and is the**

1 son of †Gonzalo Meno Taitague and †Ana Leon Guerrero Taitague; and he is the proud
2 father of Jimmy Crisostomo Taitague, and the grandfather of Taisen, Taylor, and
3 Terrance Taitague; and

4 **WHEREAS**, Uncle Dave began his civil service career in 1970 at the U.S. Navy
5 Public Works Center (U.S. NPWC) Guam, serving as a Utility Systems Operator; and

6 **WHEREAS**, during his tenure at the U.S. NPWC, Uncle Dave was recognized
7 and honored with distinguished awards, such as the Employee of the Year, December
8 1997; the Employee of the Quarter, August 1997; the Meritorious Service Award,
9 September 1998; and the Semper Service Award, 2000; and

10 **WHEREAS**, Uncle Dave's contributions to the U.S. NPWC, and to Guam,
11 included his disaster recovery efforts after Typhoon Russ, Typhoon Yuri, Typhoon
12 Omar, Typhoon Paka, the Great Earthquake of 1993, as well as Operations Desert
13 Shield and Desert Storm, the Korean Air Flight 801 Crash Recovery, Operation
14 Pacific Heaven, and the Multi-National Exercise Tandem Thrust in 1999; and

15 **WHEREAS**, in 2000, Uncle Dave retired from the U.S. Navy Public Works
16 Center after 30 years of dedicated civil service; and

17 **WHEREAS**, from 2000 to 2005, Uncle Dave's service to our people continued,
18 working with Raytheon as the maintenance leadsman; and from 2005 to 2008,
19 working at DZSP 21 as a maintenance worker, always contributing to the success of
20 these organizations; and

21 **WHEREAS**, in 2008, Uncle Dave began his public service in the government
22 of Guam at the Department of Mental Health and Substance Abuse, where he served
23 as a member of the maintenance department; and

24 **WHEREAS**, Uncle Dave's contributions to the Department of Mental Health
25 and Substance Abuse have positively played out in the return of the Department to the

1 government of Guam after years under the court-ordered Federal Management Team;
2 and

3 **WHEREAS**, Uncle Dave is committed to the professional development of all
4 employees as his training and contributions to the organization have helped “open the
5 doors” for others to excel in their work; and

6 **WHEREAS**, Uncle Dave’s expertise and willingness to teach others made him
7 an invaluable asset to the Department. Not only has he dedicated 43years of quality
8 service to the government of Guam, and private and civil service, but he has an
9 outstanding and positive attitude that fosters an environment of *esprit de corps*; and

10 **WHEREAS**, during his retirement, Dave plans to continually foster the love
11 and care he has for his family, and most especially for his grandchildren; and

12 **WHEREAS**, in his retirement, Uncle Dave will continue to provide assistance
13 and support to the parish family of San Isidro Catholic Church in *Malojloj*, where he
14 has made significant contributions as a member of the parish for over 40; and

15 **WHEREAS**, Dave’s colleagues are honored to have had the pleasure of
16 working with Uncle Dave over the years, and offer him best wishes in his future
17 endeavors as he pursues new adventures as a retiree; now therefore, be it


18 **RESOLVED**, that the Committee on Rules of *I Mina'TrentaiDosNa*
