6 Year,” as she expressed her sincere efforts in assisting with the healthcare needs of
7 our island community; and

8 **WHEREAS**, in November 2006, Ms. Judy Salas joined the GMH Volunteers
9 Association through the invitation of Ms. Evelyn Akimoto. She started working at
10 the GMH Gift Shop, as well as helping with the Gift Cart Ladies, and her skills in

13 GMHVA. She devised a system that enabled the volunteers to monitor the conducting
14 of major fundraising activities, such as the issuance of tickets, and her system enabled

16 **WHEREAS**, since her involvement with the Association, Judy has volunteered
17 her time in helping at the Gift Shop. She assisted in getting the cart operation started
18 and keeping track of its sales and reports, and she assisted and trained the cashiers and
19 volunteers in the aspects of retail and sales. She also was responsible for the volunteer
20 scheduling, as well as the inventory of the Gift Shop. Her accountability with her
21 work was admired by her colleagues, in which she had also created a format in the
