1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**

3 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios was born on October 8,
4 1941; and he was called to his eternal reward on April 6, 2013, at the age of 71; and

5 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios is the son of the late
6 Enrique L.G. “Brigido” and the late Francisca Perez Guerrero Rios; and

1 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios married Carmelita L.G.
2 Rios, and they were blessed with seven children; and

3 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios was an active member of
4 the Community Assisted Policing Effort (CAPE) Program; and

5 **WHEREAS**, in July 2012, the late Ernesto “Ernie” Guerrero Rios was
6 recognized by the Department of Integrated Services for Individuals with Disabilities
7 (DISID) for his commitment and excellent performance as a CAPE volunteer; and

8 **WHEREAS**, in May 2012, the late Ernesto “Ernie” Guerrero Rios was
9 nominated as a Master *Tubajeru/Tuberu*, and was an honoree of the Guam Masters
10 Award Program by the Guam Council on the Arts and Humanities Agency (CAHA);
11 and he is also known as a third generation Master *Tubajeru*; and

12 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios was also a local
13 entrepreneur and vendor at the *Chamorro* Village Wednesday Night Market selling
14 *tuba*, *ifit* clocks, and plaques of art; and he also taught the art of the *tuba* making craft
15 at schools and cultural events; and

16 **WHEREAS**, in 1961, the late Ernesto Guerrero Rios became a civil service
17 employee and worked at the paint shop of the Civil Engineering Division at Andersen
18 Air Force Base; and he was promoted to the HVAC Shop, where he was the top
19 skilled electrical and mechanical technician, and retired after 36 years of honorable
20 service; and


21 **WHEREAS**, the late Ernesto “Ernie” Guerrero Rios was a man of honor and

26 of Guam, recognize and memorialize the late Ernesto “Ernie” Guerrero Rios for his


1 many achievements and accomplishments; and does further extend sincere

6 Rios; and to the Honorable Edward J.B. Calvo, *I Maga’lahen Guåhan*.


