6 from John F. Kennedy High School; and

7           **WHEREAS**, working as a dedicated government of Guam employee from  
8 1971 to 2012, Lourdes had held several positions and worked within different  
9 departments of the Guam Waterworks Authority; and

10          **WHEREAS**, from 2012 to 2013, Lourdes was promoted, and served as an  
11 Administrative Officer; and

9 the people of Guam; and be it further


10 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,
