3 **WHEREAS**, the Guam Swimming Federation (GSF) is Guam's national
4 organization for competitive swimming; and

1 **WHEREAS**, the GSF is a non-profit organization whose funding comes from
2 the dues received from its member swim teams; and

3 **WHEREAS**, the current Board of Directors of the GSF consists of Edwin
4 Ching, Greta Dueñas, Mark Mamczarz, Michael Sablan, Maria Cruz, Jovy Lacson and
5 Elizabeth Atoigue; and

6 **WHEREAS**, the GSF is responsible for developing and preparing Guam’s
7 young swimmers for international competitions, including the South Pacific Games,
8 the World Championships, and the Olympics; and

9 **WHEREAS**, on May 4, 2013, the GSF will host the GSF Invitational
10 Pentathlon at the *Hagåtña* Swimming Pool; and

11 **WHEREAS**, the GSF will host participants, representing various locations
12 from across the Micronesian region, who will compete in five events to determine the
13 region’s best all-around swimmer. The events that will make up the Pentathlon are
14 the 100-meter butterfly, the 100-meter backstroke, the 100-meter breaststroke, the
15 100-meter freestyle, and the 200-meter individual medley; and

16 **WHEREAS**, in addition to the athletic benefits, swimming promotes a
17 healthier lifestyle, teaches life-saving skills, improves self-esteem and self-worth, and
18 provides a deterrent to negative behavior by providing an outlet for expression,
19 friendship, and a feeling of worth; now therefore, be it


20 **RESOLVED**, that *I Mina’Trentai Dos Na Liheslaturan Guåhan* does hereby,
21 on behalf of the people of Guam, recognize and commend the Guam Swimming
22 Federation for its support and contributions to Guam’s athletic community, and for its
23 continued assistance in the development of competitive swimmers from Guam; and
24 does further congratulate the Guam Swimming Federation for hosting this year’s GSF
25 Invitational Pentathlon; and be it further
