2 determination of the cancer survivors, their caregivers, and the lives of those lost to
3 this disease; and

4 **WHEREAS**, it is known that cancer does not discriminate. Cancer is
5 infectious in that it not only affects the entire being of a loved one, but also affects our
6 community; and

7 **WHEREAS**, the pain and health of the cancer survivor is felt in their family
8 and friends, for it is part of our culture of love and care that we never want to witness
9 this disease affect our loved ones; and

10 **WHEREAS**, it is the inner “Superhero” who continues to fight cancer every
11 day who show us what true strength really is; and

12 **WHEREAS**, many “Superheroes” who live with cancer are faced with
13 financial struggles, access to medical care, and the lack of support and community
14 awareness; and

15 **WHEREAS**, our island community stands with each cancer patient, bringing a
16 sense of hope and support in their constant fight to survive; and that in bringing
17 awareness to our community, we can continue to build the support each patient needs;

19 **WHEREAS**, our island’s “Superheroes” exist not only in the cancer patients
20 and caregivers, but also in the various organizations that make it their daily mission to
21 provide support for greater health and wellness to all cancer patients in their fight, and
22 bringing light to their darkness within their organizational abilities; and

24 this disease; and their family members, who have stood by in care and support,
25 continue to be a guiding light for those who continually fight this disease; and

1 **WHEREAS**, the resilient spirit of our island people in the face of adversity
2 represents the heart and soul, will and passion of each survivor that gives us the
3 inspiration to fight with them; now therefore, be it
