- WHEREAS, the Adult and Juvenile Drug Courts were recognized as courts of
- 4 record of the Judiciary of Guam in December 2005; and

1	WHEREAS, these programs are examples of "therapeutic justice," which focus
2	on the rehabilitation of offenders and their reintegration into society; and
3	WHEREAS, from May 9, 2003, to May 17, 2013, the Juvenile Drug Court
4	(JDC) saw 281 youths graduate from its Intensive Track; and
5	WHEREAS, the Juvenile Drug Court operates and works with over 300 JDC
6	students annually, along with an active caseload of 261; and
7	WHEREAS, to date, 252 individuals graduated from the Adult Drug Court
8	(ADC) I, while six graduated from ADC II, with 30 percent of those graduating
9	becoming employed by the program's completion date; and
10	WHEREAS, the administrators of the Drug Offender Re-Entry Program
11	(DORE) within the District Court of Guam, which was established in August 2008,
12	upheld a goal to ensure that through intensive supervision, participants are drug-free
13	as they transition into the community; and
14	WHEREAS, as of March 2013, twenty participants have graduated from the
15	federal Drug Offender Re-Entry Program, while there are currently eight participants
16	in the program; and
17	WHEREAS, on the local and national level, Drug Courts have been proven to
18	reduce crime, save taxpayer money, and combat addiction; and
19	WHEREAS, each year, "National Drug Court Month" is a time to shine a light
20	on the impact of Drug Courts, allowing the opportunity to celebrate the work of
21	professionals, whose efforts have restored lives, reunited families and made
22	communities across the nation safer for the past two decades; and
23	WHEREAS, hundreds of program evaluations and meta-analytic studies have
24	concluded that Drug Courts significantly reduce crime, as much as 45 percent more
25	than sentencing options; and
