11 and then to Tax Technician III; and

12          **WHEREAS**, Ms. Meno was promoted to serve as Supervisor of the Electronic  
13 Processing Branch on September 11, 1989; and

14          **WHEREAS**, in 2012, Ms. Meno was nominated and recognized as “Supervisor  
15 of the Year” under the Governor’s Employee Recognition Program Award of  
16 Excellence; and

17          **WHEREAS**, Ms. Meno is married to Mr. David M. Meno; and

18          **WHEREAS**, during the course of Ms. Meno’s employment with the DRT, she  
19 had also served her island and country concurrently with the 44<sup>th</sup> Aerial Port Squadron  
20 as a computer specialist with the U.S. Air Force Reserves, where she retired after 23  
21 years of service and was honorably discharged at the rank of Master Sergeant; now

2 people of Guam; and be it further


3 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules


