1 **WHEREAS**, Dr. Lucio C. Tan had the foresight and initiative to believe in
2 Guam, its future, and its people; and

3 **WHEREAS**, over the years, Dr. Tan has demonstrated his confidence and faith
4 in the island of Guam by investing and creating major business entities, the largest of
5 which was the opening of the Micronesia Mall on August 8, 1988; and

6 **WHEREAS**, Dr. Tan and the companies he owns and operates on Guam
7 include the Micronesia Mall, American Bakery, Goodwind Development, Grandview
8 Development LLC, Grandspan, Philippine Airlines and Toppo Furniture, which are
9 active members of the business community providing products, services and
10 employment opportunities for the island; and

11 **WHEREAS**, Dr. Tan and the officers and management of Goodwind
12 Development, as well as its sister companies, have shown overwhelming support of
13 Guam's charitable, fraternal and civic organizations through management and
14 participation, financial contributions, and by providing a venue for public awareness;
15 and

16 **WHEREAS**, in June 1997, Dr. Tan commenced the expansion of the
17 Micronesia Mall, doubling the size in 1999 in order to provide resident and tourist
18 shoppers with the finest variety of retail stores, restaurants and entertainment in one
19 location; and

20 **WHEREAS**, beginning in 2004 until 2008, the Micronesia Mall provided the
21 rent-free premises that became the home of the 2,000 square feet Guam Museum
22 Exhibit, located on the ground level, which provided a location for the viewing of
23 Guam's historical artifacts and an opportunity to showcase the culture and heritage of
24 Guam. Since then, about 200,000 locals, students, and visitors have toured the Exhibit
25 and were provided with an education of the Guam story; and

1 **WHEREAS**, today, the Micronesia Mall is a family-friendly facility that
2 provides its customers with shopping, dining and entertainment, to include a twelve
3 screen stadium movie theatre; an indoor amusement park; over twenty food court
4 restaurants; and various retail outlets, such as Macy's, one of America's biggest
5 department store chains for locals and tourists to enjoy; and

6 **WHEREAS**, moreover, the Micronesia Mall generates and contributes to
7 commerce on Guam, as it provides numerous employment opportunities and tax
8 revenues, while catering to the needs and desires of the people of Guam and its
9 visitors for the past twenty-five years; and


10 **WHEREAS**, the Micronesia Mall is the largest shopping center on Guam and
11 its prosperity is well appreciated by the island community; now therefore, be it

12 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
13 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
14 of Guam, commend and congratulate Dr. Lucio C. Tan and the Micronesia Mall on
15 the occasion of the Micronesia Mall's Twenty-Fifth (25th) Year Anniversary; and does
