

AN ACT TO APPROVE AND ACCEPT THE TERMS AND CONDITIONS OF THE RENEWAL OF THE APPENDED LEASE AGREEMENT BETWEEN LESSEE, THE UNITED STATES POST OFFICE, AND LESSOR, I LIHESLATURAN GUÅHAN, SUCH LEASE AGREEMENT TO COVER A PERIOD OF FIVE (5) YEARS, TO BEGIN ON AUGUST 22, 2013, FOR THE U.S. POST OFFICE BUILDING IN HAGÅTÑA.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF I

- 2 MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:
- WHEREAS, § 79601 of Article 6, Chapter 79, Title 21, Guam Code
- 4 Annotated, the "Guam Capitol District," states the following:
- 5 "The Guam Capitol District is hereby established, consisting of the grounds and
- 6 structures comprising the old Guam Congress Building (the old legislative building),
- 7 Skinner Plaza, Plaza de España, the Manuel F.L. Guerrero Administration Building
- 8 and, upon the termination or expiration of any leases attached to the property, the Post
- 9 Office in Hagåtña. Properties included in the Guam Capitol are hereby placed under
- 10 the control and supervision of *I Liheslaturan Guåhan*."; and
- WHEREAS, under such authority as granted above, I Liheslatura has, for the
- past two months, been negotiating a new five-year lease with the United States Postal
- 13 Service (USPS), the new contract period to begin on August 22, 2013, and end on

- 1 August 21, 2018, such contractual agreements having been in place for many years;
- 2 and
- 3 **WHEREAS**, under the finalized, renegotiated terms of *I Liheslatura's*
- 4 agreement with Coldwell Banker Richard Ellis, Inc. (CBRE), which firm the USPS
- 5 has contracted to provide "transaction management services," CBRE (on behalf of
- 6 USPS) has agreed with *I Liheslatura* that the monthly rental amount will increase by
- 7 17.6%, from the present amount of Sixteen Thousand Seven Hundred Eighty-five
- 8 Dollars (\$16,785) to the new amount of Nineteen Thousand Seven Hundred Forty-
- 9 seven Dollars (\$19,747), beginning with the August 22, 2013 payment; and
- WHEREAS, CBRE shall receive a commission for the provision of such transaction management services, the commission to be paid by the lessor in the
- 12 amount of Thirty Thousand Dollars (\$30,000), a reduction of more than Five
- 13 Thousand Five Hundred Dollars (\$5,500) from the previously negotiated 3% of the
- 14 total amount to be paid over the course of the five-year lease; now therefore, be it
- 15 **RESOLVED,** that the Committee on Rules of *I Mina'Trentai Dos Na*
- 16 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the people
- 17 of Guam, accept the terms of the contractual agreement to continue to lease the
- property of the Post Office building in Hagåtña to the United States Postal Service
- 19 (USPS), in the amount of Nineteen Thousand Seven Hundred Forty-seven Dollars
- 20 (\$19,747) per month, such agreement to be implemented by the Executive Director of
- 21 *I Liheslaturan Guåhan*; and be it further
- 22 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
- 23 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the people
- 24 of Guam, additionally approve a one-time payment in the amount of Thirty Thousand
- Dollars (\$30,000) from the Capitol District Fund to Coldwell Banker Richard Ellis,
- 26 Inc. (CBRE), which firm the USPS has contracted to provide "transaction

- 1 management services" relative to the lease of the property of the Post Office building
- 2 in Hagåtña to the United States Postal Service (USPS), such payment to be carried out
- 3 by the Executive Director of *I Liheslaturan Guåhan*; and be it further
- 4 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
- 5 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
- 6 the same be thereafter transmitted to the United States Postal Service; to Coldwell
- 7 Banker Richard Ellis, Inc. (CBRE); and to the Honorable Edward J.B. Calvo, I
- 8 Maga'lahen Guåhan.
