7 help open the Outrigger Hotel in 1999; and

9 years of tourism on Guam, “Mommy Nena” also celebrates nearly 42 years of
10 working in Guam’s tourism industry; and

11 **WHEREAS**, “Mommy Nena” has shown an extraordinary dedication to the *Hafa*
12 *Adai* Spirit of Guam; and

13 **WHEREAS**, Nena’s hard work, perseverance, team spirit, and attention to detail is
14 indicative of her commitment to ensuring that the engine of Guam’s economy, the

21 outstanding service working in Guam’s tourism industry; and be it further


22 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
