5 were united in the Holy Bonds of Matrimony on September 16, 1950, at the San
6 Juan Bautista Catholic Church in *Ordot*, Guam, with their family and friends in
7 attendance; and

8 **WHEREAS**, Ben Arceo served honorably in the United States Army during

14 happy years together; and be it further


15 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
