1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÁHAN:***

3           **WHEREAS**, the boonie pepper, or *donne'*, serves as an integral part of Guam's  
4 culture, and has steadily become a culinary staple that adds flavor and spice to a wide  
5 assortment of Guam's local cuisine; and

1           **WHEREAS**, in 2010, the *Mangilao* Mayor’s Office, the *Mangilao* Municipal  
2 Planning Council, and the residents of the municipality of *Mangilao* organized the  
3 first *Mangilao Donne’* Festival. The event sought to showcase not only the various  
4 uses of *donne’* in food, but also the agricultural importance of the pepper plant on  
5 Guam; and

6           **WHEREAS**, the initial *Mangilao Donne’* Festival was a part of the Guam  
7 Visitors Bureau’s overall “We Are Guam” branding initiative and marketing  
8 campaign, which focused on highlighting certain cultural aspects that make Guam,  
9 and its people, special and unique; and

10           **WHEREAS**, the *Mangilao Donne’* Festival continues to grow every year,  
11 attracting Guam residents and visitors to the municipality of *Mangilao* to enjoy food,  
12 entertainment, and contests; and

13           **WHEREAS**, the festivities for the 2013 *Mangilao Donne’* Festival will include  
14 cooking contests featuring the *donne’* as a main ingredient; a contest to choose the  
15 most beautiful *donne’* plant; the crowning of the 2013 Miss *Mangilao Donne’*  
16 Festival; entertainment and performances from different community groups and  
17 organizations; and various merchandise vendors; and

18           **WHEREAS**, the *Mangilao Donne’* Festival is a great opportunity for the  
19 residents of *Mangilao*, and the people of Guam, to come together and demonstrate the  
20 different uses of *donne’*, and its significance to Guam’s culture, and to showcase the  
21 ingenuity and entrepreneurial spirit of our people; and

22           **WHEREAS**, the *Mangilao Donne’* Festival serves as an incubator for small  
23 businesses and gives an opportunity for members of our community to showcase their  
24 products and talents to other local residents and visitors from around the world; and

25           **WHEREAS**, initiatives such as the *Mangilao Donne’* Festival promote our  
26 small business economy and a prosperous economic future by offering our people,

1 through their own hard work, the opportunity to test the commercial viability of their  
2 products and talents; now therefore, be it  
3 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na Liheslaturan*  
4 *Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam,  
5 recognize the *Mangilao* Mayor, Vice Mayor and staff of the *Mangilao* Mayor's  
6 Office, the *Mangilao* Municipal Planning Council, and the residents of *Mangilao* for  
7 coordinating and hosting the 2013 *Mangilao Donne'* Festival; and does further


