7 Nursing Degree from the University of the Philippines; and after passing the Board
8 Exam, she worked as a Staff Nurse at St. Luke's Hospital in Quezon City, and then
9 transferred to the Department of Health to serve as a Public Health Nurse; and later,
10 she became the Nursing Program Supervisor after completing her Master's in Public
11 Health Degree; and

12 **WHEREAS**, on September 29, 1963, Eliseo and Alejandrina Cacho were
13 married at the Lourdes Church in Quezon City, Philippines, starting their married life
14 in the province of Bulacan, where Mrs. Cacho was employed; and

15 **WHEREAS**, after three years of marriage, and with medical intervention, they
16 began their family with their first-born child; and

17 **WHEREAS**, Mr. Arnold Cacho, their first-born child, was born on October 17,
18 1966; and is a lawyer in private practice, and also a Professor of the College of Law at
19 the University of Santo Tomas in the Philippines; and

20 **WHEREAS**, their second child, Ms. Lourdes Esperanza C. Jos, or Leslie, was
21 born on September 4, 1967; and is a Doctor of Medicine serving as the Assistant
22 Medical Director for the Maritime Clinic for International Seafarers; and

8 leaving their two older children, who were unable to move due to their age; and

9 **WHEREAS**, Mr. and Mrs. Cacho began a “new life” on Guam, with both of
10 them having to work two jobs to sustain and support their family, which enabled them
11 to purchase their first home in 1991; and

12 **WHEREAS**, Mr. Cacho retired in 2001; and later, Mrs. Cacho retired from the
13 FHP Clinic in 2003, and the Department of Public Health and Social Services in 2008;
14 and

15 **WHEREAS**, Mr. and Mrs. Cacho are now enjoying their retirement, allowing
16 them to travel abroad every six months to California, Las Vegas and the Philippines to
17 visit with their children and grandchildren; and

18 **WHEREAS**, Mr. and Mrs. Cacho participate in physical exercise every
19 morning with the *Dededo* Aerobics Club, and are active members of the *Dededo*
20 Senior Citizens’ Center, where they enjoy playing bingo and card games, and relaxing
21 and socializing with other senior citizens; now therefore, be it


22 **RESOLVED**, that the Committee on Rules of *I Mina’Trentai Dos Na*
