4 **WHEREAS**, the Aklan Association of Guam is now served by the Officers

8 Assistant Treasurer; Marivic M. Luces, Auditor; Elsie Doroteo, Business Manager;

11 **WHEREAS**, the Board of Directors of the Aklan Association of Guam for

17 **WHEREAS**, the Ex-Officio Advisors of the Aklan Association of Guam for
18 2013-2015 are Johnny Q. Luces, Aurelio S. Solidum, Linda M. Higa, Antonio S.
19 Luces, Dubel S.M. Conlu, Roy Adonay and Rolfe G. Banes; and

20 **WHEREAS**, the mission of the Aklan Association of Guam is to establish a
21 single and unified association of Aklanons residing on Guam, which shall embody
22 their ideals of unity, civic spirit and brotherhood, and preserve the worthy and
23 cherished cultures and traditions of the province of Aklan; to render assistance to
24 the people of both the mother country, the Philippines, and the country of adoption;
25 and to promote the individual and collective welfare of each member; and

26 **WHEREAS**, the Aklan Association of Guam was also formed for the
27 purposes of uniting and promoting closer relations and camaraderie among fellow
28 Aklanons; to render aid and to assist fellow members to cooperate with the

1 authorities of Guam in the maintenance of peace and order among Filipinos; to
2 assist the Philippine Consulate General in its civic, cultural and social activities;
3 and to provide recreational activities and entertainment among its members; and

4 **WHEREAS**, the Aklan Association of Guam has positively promoted its
5 organization through various charitable and civic endeavors, to include the
6 construction and completion of a picnic shelter at the Governor Joseph Flores
7 (*Ypao*) Beach Park; the donation of six (6) wheelchairs to the Guam Memorial
8 Hospital Authority; the donation of wheelchairs and blood pressure apparatus to
9 the Kalibo Provincial Hospital in Kalibo, Aklan, Philippines; financial assistance
10 for disaster relief of the victims of the flooding and typhoon, in 2006; assistance to
11 the Filipino Community of Guam during fundraising efforts; and the underwriting
12 of tuition fees for four scholars enrolled at the Aklan College through graduation;

14 **WHEREAS**, the Aklan Association of Guam continually plays an active
15 role in brotherhood and unity by participating in the annual Guam Liberation Day
16 Parade; and the American Cancer Society Cancer Survivors Walk and Airplane
17 Pull; and

18 **WHEREAS**, the members of the Aklan Association of Guam continue to
19 play an active role in the community through their participation in other civic,
20 educational and cultural organizations, such as the Guam Lions Clubs and the
21 Guam Memorial Hospital Volunteer Association; and

22 **WHEREAS**, the Aklan Association of Guam is an active member of the
23 Filipino Community of Guam, and is a founding member of the *Santo Niño* Guam
24 in 2000, which annually celebrates the feast of the *Santo Niño* every second
25 Sunday of January; now therefore, be it

26 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
27 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
28 people of Guam, commend and congratulate the Aklan Association of Guam on the

1 occasion of its 48th Year Anniversary and Induction of Officers and Board of
2 Directors for 2013-2015; and does further extend a warm *Un Dångkolo Na Si*
3 *Yu'os Ma'åse'* to the Aklan Association of Guam for its commitment to fostering

10 *Maga'laken Guåhan*.


