4 Officer II, and was assigned to work in the DRT Tax Collection Branch; and

5 **WHEREAS**, on September 27, 2013, Concepcion A. Aguero will retire from the  
6 government of Guam after serving as a Revenue Officer III with the DRT Tax Collection  
7 Branch; and her institutional knowledge will be greatly missed by her colleagues at the  
8 Department of Revenue and Taxation; now therefore, be it

18 J.B. Calvo, *I Maga'lahaen Guåhan*.


