1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2        ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS**, 101.9 FM was established by KM Broadcasting of Guam, L.L.C.,  
4        on June 9, 2003, at the Boonsri Plaza in Upper *Tumon*; and

5        **WHEREAS**, it was the vision of KM Broadcasting of Guam and their General  
6        Manager, Mr. Rolando Manuntag, also known as “Rolly M.,” to feature Oldies Music  
7        radio programs; and

1           **WHEREAS**, with the addition of Mr. Miguel Ocampo, also known as “Migz,”  
2 Original Pinoy Music was introduced on the radio airwaves; and

3           **WHEREAS**, in 2004, after the first year of operation, they were able to attract  
4 their first on-air advertisers, including, Seaside Fish Mart, Gabriel Technologies and A  
5 & A Pawnshop; and

6           **WHEREAS**, the team of Rolly M. and Migz decided they needed to expand  
7 their team to include an Accountant, a Sales and Marketing Manager, and a  
8 Production Manager, thus employing the expertise of Ms. Gloria Diaz, Ms. Krista  
9 Gaza, and Mr. Jon Sabares, respectively; and

10           **WHEREAS**, with Mr. Jon Sabares’ talent, a crossover playlist was introduced  
11 to coexist with the Original Pinoy Music, and thus the brand MEGAMIXX was born,  
12 enabling 101.9 FM to play various musical genres to support the local and Filipino  
13 population on Guam; and

14           **WHEREAS**, MEGAMIXX has grown to include numerous individuals who  
15 play an integral part of the success of MEGAMIXX, namely, Arnold “DJ Arnold”  
16 Sapida, Production Manager; Eduardo “Toods” Tuason, Traffic Director; Gary “DJ  
17 Cure” Encarnacion, Marketing and Sales Director; and Natassia “DJ Tash” Nave,  
18 Sales Manager; and

19           **WHEREAS**, since 2003, they have opened the doors to more listeners and  
20 numerous disc jockeys in Rolly Manuntag, Gloria Diaz, Mike Ocampo, Arnold  
21 Sapida, Gary Encarnacion, Melanie Fauni, Eduardo Tuason, Rafael Magsino, Donna  
22 De Jesus, Vanessa Malumay, Vlad Navasca, Nastassia Nave, and Johnny Zilian; and

23           **WHEREAS**, the goal to bring family-friendly and quality radio broadcasting to  
24 Guam is evident in the inclusion of new advertisers and a broader listening audience,  
25 supported by the #1 Chart placement for 2012’s Top of the Mind Radio Station, as  
26 conducted by the Market Research and Development survey; and


1           **WHEREAS**, MEGAMIXX has begun a “Jr. Jock” summer program aimed at  
2 promoting radio broadcasting to students in high school and college, giving them  
3 opportunities for a career in broadcasting and production; and


4           **WHEREAS**, it is the commitment and desire of MEGAMIXX 101.9 FM to be  
5 the “True Voice of the Filipinos” on Guam; now therefore, be it


6           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
