1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***

3           **WHEREAS,** Mr. Thomas M. Cepeda was born on April 29, 1957, and is the  
4 son of Jesus A. and Maria M. Cepeda. Thomas resides in the village of *Chalan Pago*  
5 with his wife, Maria T. Cepeda, and their son, Thomas T. Cepeda Jr.; and

1           **WHEREAS**, Mr. Thomas M. Cepeda began his government of Guam career in  
2 1986, working as a Solid Waste Technician at the Department of Public Works Solid  
3 Waste Management Division, a position he held until 1998; and

4           **WHEREAS**, in 1998, Mr. Thomas M. Cepeda was promoted to the position of  
5 Equipment Operator III, and was posted at the landfill in *Ordot*; and

6           **WHEREAS**, in 2010, Mr. Thomas M. Cepeda was assigned to serve as a team  
7 leader of the residential collection and the new bulky waste collection services; and,

8           **WHEREAS**, since 2010, Mr. Thomas M. Cepeda has worked with fellow  
9 Guam Solid Waste Authority employees, and the community, in the efforts to close  
10 the landfill in *Ordot*; and

11 **WHEREAS**, during his tenure serving at the Guam Solid Waste Authority, Mr.  
12 Thomas M. Cepeda had worked effectively and tirelessly to assist in producing major  
13 improvements at the landfill in *Ordot*; and he would always work to cover the solid  
14 waste at the landfill daily to help resolve the potential health hazards and  
15 overwhelming odor brought to the residents of *Ordot*; and

16           **WHEREAS**, Mr. Thomas M. Cepeda has garnered the utmost respect and  
17 appreciation from fellow employees who have had the opportunity to work alongside  
18 him, as well as their families, and the community; and

19           **WHEREAS**, for a significant portion of his professional life, Mr. Thomas M.  
20 Cepeda had dedicated himself to the safety and health of the environment and the  
21 people of Guam; and

22           **WHEREAS**, Mr. Thomas M. Cepeda has decided to retire in September 2013  
23 after twenty-seven (27) years of public service, and he has left a positive mark on the  
24 Guam Solid Waste Authority; and

25           **WHEREAS**, our island community, and the colleagues, family, and friends of  
26 Thomas wish him the best on his well-deserved retirement; now therefore, be it

1           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*  
2 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
3 of Guam, recognize and commend Mr. Thomas M. Cepeda for his twenty-seven (27)


