3 **WHEREAS,** Dr. Annette M. David is one of the founders of Health Partners,
4 LLC, a full-service health care organization that provides clinical and consultative health
5 services to the community of Guam; and

6 **WHEREAS,** as a Senior Partner, Dr. David oversees the organization’s
7 Preventative and Public Health Consultative Services Division; and

1 **WHEREAS**, Dr. David graduated summa cum laude from the University of the
2 Philippines, and she completed her Masters Degree in Public Health at Columbia
3 University in New York; and

4 **WHEREAS**, during her residency for internal medicine at the State University of
5 New York at Stony Brook, Dr. David was elected into the Alpha Omega Alpha Medical
6 Honor Society; and

7 **WHEREAS**, Dr. David is a Fellow of the American College of Occupational and
8 Environmental Medicine, and the Philippine College of Physicians; and

9 **WHEREAS**, Dr. David is also one of the Adjunct Research Faculty at the
10 University of Guam Cancer Research Center, a Clinical Associate Professor at the
11 University of Hawai'i Cancer Center, a Technical Consultant for the Tobacco Prevention
12 and Control Program of the Guam Department of Public Health and Social Services, and
13 she sits on the advisory boards of the American Cancer Society-Guam, the Guam
14 Regional Medical Center, and the UP Alumni Association of Guam; and

15 **WHEREAS**, Dr. David serves as a Technical Consultant for the Tobacco
16 Prevention and Control Program of the Guam Department of Public Health and Social
17 Services, as well as a Consultant for the Guam Behavioral Health and Wellness Center's
18 State Epidemiological Outcomes work group; and

19 **WHEREAS**, the Filipina Women's Network, a private, non-profit organization
20 based in San Francisco, California, that was established to raise funding and awareness of
21 the activities, careers and status of women of Philippine ancestry, has selected Dr. David
22 to be one of the recipients of its Innovators and Thought Leaders Award category. This
23 award honors "women who have broken new ground in the marketplace, have delivered
24 new and unique applications of emerging technology, transforming the way people think
25 in the fields of sports, literature, the arts, and pop culture, or have improved the lives of
26 others by helping develop a product or service in the fields of science, engineering,
27 technology, or medicine; and

1 **WHEREAS**, Dr. David will be honored, along with the other Filipina Women’s
2 Network Global 100 Awardees, at the 10th Annual Filipina Leadership Summit, to be
3 held at the Mark Hopkins Intercontinental Hotel in San Francisco from October 24 to

15 J.B. Calvo, *I Maga’lahen Guåhan*.


