# 1BE IT RESOLVED BY THE COMMITTEE ON RULES OF I2MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:

3 WHEREAS, World AIDS Day is observed on the 1st of December every year, 4 and it is an opportunity for people worldwide to unite in the fight against HIV, to show their support for people living with HIV, and to commemorate those people who
 have died from the disease; and

WHEREAS, World AIDS Day is celebrating its 25th year of Global Health
Day, which began in 1988; and

5 WHEREAS, the Guam HIV/AIDS Network (GUÅHAN), founded by Alexis
6 Silverio, Terry Aguon, and Tim de la Cruz, is the island's AIDS Service Organization,
7 and is a project of the WestCare Pacific Islands (WCPI) organization; and

8 WHEREAS, the global theme of this year's World AIDS Day ceremony is: 9 "Shared Responsibility; Strengthening Results for an AIDS-Free Generation," while it 10 continues to strive towards its goal of "Getting to Zero: Zero AIDS-Related Deaths; 11 Zero Discrimination; Zero New Infections." 2013 marks thirty-two (32) years since 12 the first case of HIV/AIDS was confirmed; and

WHEREAS, there have been approximately two hundred forty-four (244) HIV cases diagnosed on Guam since 1985; and sixty-four (64) people are currently living with HIV on Guam. Globally, an estimated 33.3 million people have HIV. Nationally, young people between the age of thirteen (13) to twenty-nine (29) years old account for 40% of all new HIV cases; and on Guam accounts for 32%, which makes educating our island's youth about HIV/AIDS a priority; and

WHEREAS, many scientific advances have been made in HIV treatment, and there are now laws to protect people living with HIV. Despite this, however, many people still do not know the facts about how to protect themselves and others from HIV, and stigma and discrimination remain a reality for many people living with HIV; and

WHEREAS, World AIDS Day is an important occasion, as it reminds the public and the government that HIV has not gone away; and that there is still a vital need to raise money for services to increase awareness, to fight prejudice, and to

### 1 improve HIV/AIDS education; and

WHEREAS, as part of Guam's and the international community's efforts to observe December 1 as World AIDS Day, the Guam HIV/AIDS Network (GUÅHAN), a project of WestCare, with the help of Guam's Alternative Lifestyle Association (GALA), will be holding a Candlelight Vigil Ceremony at 5:30 p.m. at the WestCare Office in Tamuning; and

WHEREAS, the WestCare Pacific Islands (WCPI) organization is part of the
WestCare nationwide family of tax-exempt organizations that provide a wide
spectrum of health and human services in both residential and outpatient environments
to more than thirty thousand (30,000) youth, adults and families annually; and

WHEREAS, the WCPI organization also provides services, such as substance abuse and addiction treatment, homeless and runaway shelters, domestic violence treatment and prevention, and mental health programs; and

WHEREAS, WestCare also provides prevention education and supportive
 group counseling for girls ages twelve (12) to seventeen (17) years old, through a
 program called Project Isa-ta; and

WHEREAS, Project Isa-ta aims to reduce the risk of contracting HIV/AIDS and sexually-transmitted diseases (STDs) among our young girls, as well as to increase their self-esteem and positive body image, and to educate them on abuse and violence; now therefore, be it

RESOLVED, that the Committee on Rules of I Mina'Trentai Dos Na Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the people of Guam, commend and recognize the WestCare Pacific Islands (WCPI) organization; Alex Silverio, Terry Aguon, and Tim de la Cruz of the Guam HIV/AIDS Network (GUÅHAN) Project; the Guam Alternative Lifestyle Association (GALA); and the Department of Public Health and Social Services (DPHSS) on the occasion of the Annual Candlelight Vigil Ceremony in honor of World AIDS Day on December 1,
