- 1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***
3 **WHEREAS,** the Far East Boys Division One Basketball Tournament is the oldest
4 of all the Department of Defense Education Activity (DoDEA) Pacific Far East events,
5 the first one being held in 1949; and

1 **WHEREAS**, prior to 1993, Guam had never won the Far East Division One Boys
2 Basketball Tournament; and

3 **WHEREAS**, in 1993, Felipe Candaso single-handedly mentored and coached the
4 Oceanview Knights boys basketball team; and

5 **WHEREAS**, the team consisted of Lloyd Lagutang, Jesse Pinaula, Ron Taitague,
6 Tommy Morrison, Cy Concepcion, Theo Cook, Kurt Sanchez, Ryan Pinaula, Ray
7 Mantanona, Richard Gutierrez, Mike Rabago, and Joshua Grey; and

8 **WHEREAS**, Coach Felipe Candaso compensated for the team's lack of size by
9 focusing the athletes on speed, teamwork, and creating an impenetrable defense; and

10 **WHEREAS**, in 1993, Coach Felipe Candaso instilled the values of discipline,
11 work ethic, and camaraderie with his athletes that still exists today; and

12 **WHEREAS**, this focus on training and values led the Oceanview Knights to an
13 undefeated Interscholastic Basketball League season, and they were the boys basketball
14 champions on Guam in 1993; and

15 **WHEREAS**, the Guam Oceanview Knights went to the Far East Boys Division
16 One Basketball Tournament, held at Yokota Air Force Base in Japan, where they were
17 the underdogs but would beat favored opponents, including the tournament favorite
18 Kadena High School; and

19 **WHEREAS**, Coach Felipe Candaso and the Oceanview Knights would prevail in
20 the championship game against the home team, Yokota Panthers, with the score of 64-57;
21 and they became the first team from Guam to win the Far East Boys Division One
22 Basketball title in the tournament's sixty-four year history; and


23 **WHEREAS**, Coach Felipe Candaso loves the sport of basketball, and he has
24 sacrificed countless hours and days to coach young athletes in this sport; and this
25 motivation, drive, passion, and professionalism molded this team and others for success
26 in the sport of basketball, and in life; and

1 **WHEREAS**, Coach Felipe Candaso has left his indelible impression on the hearts
2 and lives of the young boys on this basketball team who twenty years later still recall
3 with fond memories that “brief moment” in their lives that inspired them to strive for
4 excellence; now therefore, be it


5 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na Liheslaturan*
