3 **WHEREAS, Mr. Zachary J. Pangelinan is from the village of *Yigo*; and is the**
4 **son of James J. Pangelinan and Tina M.C. Pangelinan, and the brother of Tamilyn**
5 **Marie Pangelinan and Todd Christopher Pangelinan; and**

1 **WHEREAS**, Zachary was first introduced to the sport of soccer and began
2 playing at the age of sixteen; and he excelled while playing soccer for Simon Sanchez
3 High School in 2003, 2005 and 2006, earning the title of Most Valuable Player; and
4 he was a member of the Guam Under-18 Soccer Team that won two league titles in
5 2004; and

6 **WHEREAS**, Zachary also played soccer for the Guam Shipyard Football Club
7 and won four Guam League titles between 2005 and 2006; and he played in the AFC
8 Challenge Cup in 2008; and

9 **WHEREAS**, although Zachary was an avid and talented soccer player on
10 Guam, he now plays rugby for the Old Mission Beach Athletic Club in San Diego,
11 California; and

12 **WHEREAS**, Zachary began the transition to the sport of rugby football while
13 participating in the U.S.A. Men's Sevens training camp at the Olympic Training
14 Center in Chula Vista, California, from September 2010 to May 2011, as well as at a
15 training camp in Atlanta, Georgia, in April 2013; and

16 **WHEREAS**, on November 17, 2012, Zachary made his debut for the U.S.
17 National Rugby Team in the International Rugby Series; and

18 **WHEREAS**, Zachary now plays rugby football on a professional level,
19 representing the U.S.A. Eagles; and

20 **WHEREAS**, Zachary is presently the only rugby player from Guam
21 representing the U.S. National Rugby team; now therefore, be it
