3           **WHEREAS, Mr. Walter S. Cruz is a resident of *Merizo*, and is married to Vivian**  
4 **Cruz; and they are the proud parents of three (3) children: Walter, Jr.; Neilisha; and**  
5 **Nerissa; and**

1           **WHEREAS**, Mr. Cruz began his federal service career in April 1980, working as  
2 a GS-04 Laboratory Technician in the Utilities Department, U.S. Navy Public Works  
3 Center, Guam; and

4           **WHEREAS**, in September 1980, Mr. Cruz entered the U.S. Navy Public Works  
5 Center, Guam Apprentice Program as an Electrician Equipment Repairer, and he  
6 graduated from this training program in May 1984; and

7           **WHEREAS**, five (5) months later, Mr. Cruz accepted a position at the Contracts  
8 Department, U.S. Navy Public Works Center, Guam, as a GS-07 Quality Assurance  
9 Evaluator; in 1988, he was promoted to a GS-09 Engineering Technician; and in 1989, he  
10 was again promoted to a GS-11 Engineering Technician within the same department; and

11           **WHEREAS**, in April 2000, due to rightsizing efforts as a result of converting the  
12 majority of the government workforce over to a Base Operating Support Services  
13 Contract, Mr. Cruz was reclassified as a GS-09 Spec Writer; and

14           **WHEREAS**, in 2005, the U.S. Navy Public Works Center, Guam was transformed  
15 to the Naval Facilities Engineering Command, Marianas; and in May 2005, Mr. Cruz was  
16 reinstated to his former GS-11 Engineering Technician position; and

17           **WHEREAS**, in August 2007, Mr. Cruz was promoted to a GS-12 Senior  
18 Performance Assessment Representative at NAVFAC Marianas; and in October 2007,  
19 Mr. Cruz received a lateral assignment to serve as a GS-12 Contracting Officer  
20 Representative and Facilities Maintenance Facility Services Director, and he has held that  
21 position up to the present time; and

22           **WHEREAS**, Mr. Cruz has continually demonstrated exceptional devotion to duty,  
23 and he has served through many special efforts and emergencies; and his service,  
24 commitment and dedication have been commendable in all respects; and

25           **WHEREAS**, during his successful career, Mr. Cruz received numerous citations,  
26 awards, and accolades attesting to his professionalism, dedication, superior performance,

1 and can-do attitude; and in 2003, Mr. Cruz was honored as the NAVFAC Marianas  
2 Employee of the Quarter and Employee of the Year; and

3 **WHEREAS**, after thirty-three (33) years of dedicated service in the Federal  
4 Government, from April 2, 1980 to January 3, 2014, Mr. Cruz has retired as the Facility  
5 Support Contracts Manager, GS-12, with the NAVFAC Marianas; now therefore, be it

16 Region Marianas; and to the Honorable Edward J.B. Calvo, *I Maga'lahren Guåhan*.


