7 Honolulu, Hawaii, in an effort to see how they would perform against nationally-
8 ranked teams; and

1 **WHEREAS**, the Father Dueñas Memorial School Varsity wrestling team
2 participated in the 2013 Holiday Dual Meet Wrestling Tournament held on December
3 27-28, at the Moanalua High School in Honolulu, Hawaii; and

4 **WHEREAS**, during the Tournament, the Father Dueñas Memorial School team
5 faced the top teams from Hawaii, including the defending state champion, as well as
6 teams from Washington and American Samoa; and

7 **WHEREAS**, the Father Dueñas Memorial School wrestling team defeated two
8 teams and tied with one other team; and

9 **WHEREAS**, against several nationally-ranked high school wrestling teams, the
10 Father Dueñas Memorial School wrestling team’s solid performance garnered them an
11 11th place finish; and

12 **WHEREAS**, the performance of our local wrestlers at the Holiday Dual Meet
13 Wrestling Tournament shows the immense potential for the growth of the sport of
14 wrestling on Guam; and

15 **WHEREAS**, the Father Dueñas Memorial School wrestling team’s show of
16 camaraderie and sportsmanship exemplified the best attributes of Guam and its
17 people; and

18 **WHEREAS**, the Father Dueñas Memorial School wrestling team’s
19 participation in the Tournament has the potential to grow and increase the exposure of
20 the sport of wrestling on Guam, with potentially more Guam teams participating in
21 this Tournament next year; and


22 **WHEREAS**, *I Mina'Trentai Dos Na Liheslaturan Guåhan* wishes to commend
