1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** the Association of Government Accountants (AGA) is a
4 professional organization with a network of fifteen thousand (15,000) members in
5 over one hundred (100) chapters across the United States, and around the world,
6 representing state, federal, and local governments, and private accountability
7 professionals; and

1 **WHEREAS**, the AGA, Guam Chapter has one hundred ninety-one (191)
2 members who work to uphold AGA’s mission of “Advancing Government
3 Accountability,” as it continues its broad educational efforts, with an emphasis on
4 high standards of conduct, honor and character in its *Code of Ethics*, and who are
5 making significant advances, both in its professional ability and in its service to the
6 residents of Guam, by mastering increasingly technical and complex accounting
7 requirements; and

8 **WHEREAS**, the Certified Government Financial Manager (CGFM) Program
9 of AGA provides a means of demonstrating professionalism and competency by
10 requiring CGFM candidates, twenty-four (24) of which are from the AGA, Guam
11 Chapter, to have appropriate education and professional experience, to abide by
12 AGA’s *Code of Ethics*, and to pass three (3) examinations requiring expertise in
13 governmental environment, governmental financial management and control, and
14 governmental accounting, financial reporting and budgeting; and also requires each
15 CGFM to maintain certification by completing at least eighty (80) hours of continuing
16 professional education in government financial management topics or related
17 technical subjects every two (2) years; and

18 **WHEREAS**, the AGA, Guam Chapter is led by President Doreen Crisostomo,
19 Ph.D., CGFM; Mr. Jose Guevara III, CGFM - CGFM Director and the Certification
20 Regional Coordinator for the AGA-Pacific Rim; and Mr. Randall V. Wiegand Sr.,
21 CGFM, CPA - AGA Regional Vice President, Pacific Rim; and

22 **WHEREAS**, these dedicated individuals lead a passionate group of people in
23 the government financial management profession, which is characterized by its efforts
24 to achieve common objectives and by its observance of certain fundamental
25 principles; these AGA CGFM members must adhere to ethical requirements to ensure

1 the highest quality of performance, and to maintain public confidence in the
2 profession; now therefore, be it


3 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
4 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
5 of Guam, recognize and commend Guam's Certified Government Financial Managers
6 (CGFM) of the Association of Government Accountants, Guam Chapter on the
7 observance of March 2014 as "CGFM Month"; and be it further
