1           **WHEREAS**, the late Lawrence “Larry” F. Vecchio was born on June 12, 1935,  
2 in South Amboy, New Jersey; and he also had lived in Utah, Nebraska, and in the  
3 Pacific region; and

4           **WHEREAS**, Mr. Vecchio was a self-employed insurance salesperson who  
5 built his own successful agency; and in 1991, he joined Surety Life and served as the  
6 Divisional Vice President of the West region, including Guam, with his region quickly  
7 becoming Surety Life’s top-ranked market; and

8           **WHEREAS**, Mr. Vecchio had worked closely with his agents from the entire  
9 western region, including Guam, and his fondness for Guam and its people would  
10 continue growing over the years; and

11           **WHEREAS**, Mr. Vecchio continued his career with Lincoln Benefit Life,  
12 eventually returning to the Financial Service Network as owner/principal, where he  
13 continued to work closely with those he appreciated and respected through the years,  
14 including lifetime friends and agents such as Jackie Flores and the late Jess Dela Cruz,  
15 among many others; and

16           **WHEREAS**, Mr. Vecchio was a member of the Knights of Columbus Council  
17 in Keyport, New Jersey; and he was also a professional entertainer with the  
18 internationally known musical group, “The Viscounts,” which performed on television  
19 and stage shows across the United States, including Dick Clark’s “American  
20 Bandstand,” and the “Merv Griffin Show,” with their most successful instrumental  
21 recording being “Harlem Nocturne,” which entered the Billboard Hot 100 charts  
22 twice, in 1959 and 1966, with Mr. Vecchio playing the electric organ; and

23           **WHEREAS**, Mr. Vecchio unexpectedly passed away on Thursday, January 10,  
24 2013, at his home in New Jersey, his passing coming soon after he was successful in  
25 expanding the benefits available to Guam from Allstate Benefits, Transamerica Life  
26 Insurance Company, and several others; and

1           **WHEREAS**, Mr. Vecchio was predeceased by his parents, Lawrence and  
2 Jennie Cusano Vecchio; and he is survived by four sons and their spouses, Lawrence  
3 J. and Patti of Holmdel, New Jersey; Anthony and Maurita of Keyport, New Jersey;  
4 Mark and Julie of Eastampton, New Jersey; and Joseph and Coleen of Keyport, New  
5 Jersey; and

6           **WHEREAS**, Mr. Vecchio is additionally survived by a stepson, Nickolas, of  
7 California; twelve grandchildren; and a great grandchild, Maddox; now therefore, be it




