4        airwaves as the first commercial radio broadcast station in Guam's history, and was

6        Ventura, California. Two years later, in 1956, KUAM spawned a television sibling,  
7        KUAM Television, an NBC affiliate; and

1           **WHEREAS**, KUAM Pacific Telestations, Inc., doing business as the stations  
2 of KUAM, has been serving the island of Guam for sixty years in the field of media  
3 communications; and

4           **WHEREAS**, KUAM has been at the forefront of providing entertainment and  
5 news programs to the people of Guam; and

6           **WHEREAS**, KUAM TV and Radio, under the management of KUAM Pacific  
7 Telestations, Inc., consists of KUAM AM 630 (Isla 63), KUAM FM 93.9 (I-94 FM),  
8 KUAM TV8 and KUAM TV11; and

9           **WHEREAS**, KUAM has remained on the cutting edge of technology; and  
10 through the establishment of kuam.com, the launch of KUAM TV8 and KUAM TV11  
11 in high definition, as well as the prolific use of various social media sites, they have  
12 kept Guamanians both at home and abroad up to date with the latest local, national  
13 and international news and entertainment; and

14           **WHEREAS**, KUAM has been awarded the prestigious and coveted Edward R.  
15 Murrow Award, MSPJ awards, and various community service designations for its  
16 distribution of news and entertainment via television, radio, and the world wide web;  
17 and

18           **WHEREAS**, KUAM has been the sponsor of numerous charitable and  
19 humanitarian events, and throughout the years, it has raised money and awareness for  
20 the assistance of the less fortunate through its programs, such as the “KUAM Care  
21 Force” and others; and

22           **WHEREAS**, *I Mina'Trentai Dos Na Liheslaturan Guåhan* wishes to commend  
23 KUAM Pacific Telestations, Inc., and its management and staff, on the milestone  
24 achievement of its Sixtieth Year Anniversary of doing business on Guam; now
