1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS,** Mindy Fothergill Aguon relocated to Guam in 1996 with her
4 family, and she has since made Guam her home. Mindy graduated from St. Paul's
5 Christian School two years later, and was the class Valedictorian. Shortly thereafter,
6 Mindy began an internship with KUAM while simultaneously attending the

1 University of Guam as a full time student. In February 2000, Mindy was hired by
2 KUAM to work as a news reporter; and

3 **WHEREAS**, during her employment with KUAM, Mindy was promoted from
4 news reporter to anchor, and then to television news anchor, due to her intense work
5 ethic and rich storytelling ability. In June 2008, Mindy was promoted to the position
6 of Assistant News Director; and

7 **WHEREAS**, Mindy had a gift for journalism that, when merged with her
8 sensitivity to the local culture and her desire to uncover the story, created an
9 unprecedented award-winning career chronicling more than fourteen years of Guam's
10 recent history. Mindy's stories have documented some of the island's most
11 challenging economic times and dealt with triumphant moments, detailing various
12 issues from the heights of human achievement to the depths of social tragedy; and

13 **WHEREAS**, Mindy had received two Micronesia Society of Professional
14 Journalists Awards in 2002 for Best Spot News and Best Online Reporting. She was
15 also awarded with the prestigious Edward R. Murrow Regional Award for Best
16 Documentary for her personal journey, "Finding My Roots." Also in 2008, Mindy was
17 featured in the KUAM production, "Survivors: In Their Own Words," which was
18 named as the 2008 Outstanding Regional Documentary, winning the Edward R.
19 Murrow Award from the Radio and Television News Directors Association; and

20 **WHEREAS**, Mindy has been the consummate team player, she has served as
21 an active member of the KUAM Care Force, and she was a fixture at many KUAM-
22 hosted community projects; and


23 **WHEREAS**, Mindy has chosen to resign from her position with KUAM to

2 acknowledge Mindy Fothergill Aguon for fourteen years of dedicated service in
