9 **WHEREAS**, in 1958, Law Day was established and proclaimed by President
10 Dwight D. Eisenhower; and in 1961, this day was reaffirmed through a Joint
11 Resolution adopted by the U.S. Congress; and

12 **WHEREAS**, as we celebrate Law Day with Americans across the nation, we
13 gather to appreciate the U.S. Constitution, and the laws that protect our rights and
14 liberties; and we further acknowledge our individual responsibilities as U.S. citizens
15 to uphold the values of a free and just society for all; and


16 **WHEREAS**, through the collaborative efforts of the Guam Bar Association; the

26 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people


1 of Guam, recognize and commend the Judiciary of Guam, the U.S. District Court of

14 States Congress; and to the Honorable Edward J.B. Calvo, *I Maga'lahren Guåhan*.


