3 **WHEREAS,** Brando Quejado's competitive nature led him to the weight room,
4 where he trained to become a better triathlete and cyclist while attending school in
5 Hawaii; and this is where he quickly fell in love with weightlifting, noticing the
6 results it had on his body, and this is how his passion for bodybuilding was born; and

1 **WHEREAS**, Brando Quejado returned to Guam, where he continued his
2 passion for bodybuilding, and his ascent in the sport began to take new heights; and

3 **WHEREAS**, Brando Quejado met with veterans of the sport, including Tony
4 Morrison, who was his coach for more than ten years, and who taught him proper
5 dieting and training; and this again elevated him to new heights in the sport of
6 bodybuilding; and

7 **WHEREAS**, Brando Quejado carries the muscle mass of a bodybuilder with
8 the proportion and aesthetics that showcase the symmetry of a champion; and this was
9 done through tenacity, discipline, and consistency; and

10 **WHEREAS**, his work ethic, discipline, and consistency over the years has
11 earned Brando Quejado multiple titles and accomplishments, including his most
12 recent Gold Medal at the International Olympic Committee (IOC) sanctioned 2011
13 Pacific Games held in Noumea, New Caledonia; and

14 **WHEREAS**, Brando Quejado's past titles also include: 1998 Guam National
15 Bantamweight Champion; 2001 Guam National Bantamweight Champion; 2007
16 Guam National Flyweight and Overall Champion; 4th Place, 2007 Mr. Philippines
17 Small Class; 7th Place, 2010 64th World Amateur Bodybuilding Championships
18 (IFBB World Championships); 2010 Pan Pacific New Zealand Bantamweight
19 Champion; 2010 Guam National Bantamweight and Overall Champion; and 2011
20 Guam National Bantamweight Champion; and

21 **WHEREAS**, while Brando Quejado's bodybuilding accomplishments are
22 exemplary and an inspiration for young athletes, through this success, he has
23 maintained humility and integrity; and

24 **WHEREAS**, like many giant men, giant obstacles have stood before Brando
25 Quejado, but like David in the Bible story, he has conquered these obstacles, and is

1 known in the sport of bodybuilding on Guam as the “Giant Slayer”; now therefore, be
2 it

3 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
4 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
5 of Guam, commend Brando Quejado for his success as an athlete for more than three

13 J.B. Calvo, *I Maga'lahaen Guåhan*.


