3           **WHEREAS**, the Department of Public Works was established by Public Law  
4 1-88, and since 1952, the men and women of the Department of Public Works have  
5 provided essential services to the people of Guam by maintaining Guam’s  
6 transportation infrastructure and assuring the safe and efficient flow of the Island’s

1 traffic; providing streetlight services for the safety of motorists and pedestrians on  
2 Guam's roadways; providing bus transportation for the Island's students; providing  
3 government-wide design, construction and maintenance of public facilities; enforcing  
4 the building code; and mitigating potential flooding and other threats to the property  
5 and lives of the public; and

6 **WHEREAS**, over the last sixty-two (62) years, the Department of Public  
7 Works has continually responded to the changing needs of our government, our  
8 Island, and its people through the planning for Guam's long-term strategy to improve  
9 transportation infrastructure and operations through the 2030 Guam Transportation  
10 Program, and improvement of customer services through the opening and operation of  
11 the Permit Center; and

12 **WHEREAS**, from 2012 to 2013, the employees of the Permit Center have  
13 processed and issued approximately two thousand eight hundred (2,800) permits to  
14 allow community members to safely build and develop property on the Island, and  
15 have collected approximately One Million Eight Hundred Thousand Dollars  
16 (\$1,800,000) in building permit fees from various business entities and individuals  
17 throughout the community, with the Permit Center establishing a convenient and  
18 efficient point of service for the people of Guam; now therefore, be it

19 **RESOLVED**, that *I Mina'Trentai Dos Na Liheslaturan Guåhan* does hereby,  
20 on behalf of the people of Guam, recognize and commend the Employees and  
21 Management of the Department of Public Works on the celebration of "*Public Works*  
22 *Week 2014*," congratulate and commend the Staff of the Permit Center on the occasion  
23 of its grand reopening; and does further express a most sincere *Un Dångkolo Na Si*  
24 *Yu'os Ma'åse'* to the Employees and Management of the Department of Public Works
