3           **WHEREAS,** Ms. Josita M. Calvo is a native of Guam from the beautiful  
4 village of *Hagåtña*; and she has a son, Kenji; and

1           **WHEREAS**, Ms. Calvo is celebrating her retirement after serving over thirty-  
2 three years in the government of Guam, with twenty-six of those years being  
3 dedicated to her service with the Judiciary of Guam; and

4           **WHEREAS**, Ms. Calvo's professional work experience with the government of  
5 Guam spans the various positions she has held in Guam's three co-equal branches of  
6 government: *I Liheslaturan Guåhan* (the Guam Legislature), where she had served for  
7 two years; the Governor's Office, where she worked for five years; and she is now  
8 retiring from government of Guam service after working at the Judiciary of Guam for  
9 twenty-six years; and

10          **WHEREAS**, Ms. Calvo's government service at the Judiciary of Guam began  
11 in April 1984, working as an Administrative Assistant; and she had climbed the ladder  
12 of success throughout these years to eventually reach her current retiring position at  
13 the Judiciary as a Court Fiscal Officer I. Josita is considered a role model amongst her  
14 colleagues for her expertise and her dedication to performing her duties; and

15          **WHEREAS**, Ms. Calvo's commitment to exceptional service has been  
16 recognized through the numerous letters of appreciation and commendation she has  
17 received. Some of her recognitions include: her January 3, 1990, Certificate of  
18 Appreciation issued by former Judge Benjamin J.F. Cruz, who is the current Vice  
19 Speaker of the 32<sup>nd</sup> Guam Legislature, for her unselfish assistance to the Judicial  
20 Branch; a January 3, 1990, Certificate of Appreciation for her contributions to the  
21 "*Ginen I' Kotte*" newsletter; and in 1991, she received a Letter of Commendation from  
22 Judge Joaquin V.E. Manibusan for her participation in the Grand Opening of the  
23 Guam Judicial Center; and

1           **WHEREAS**, Ms. Calvo’s twenty-six years of service is a testament to her  
2 commitment to helping the Judiciary of Guam fulfill its mission in upholding peace  
3 and justice for the people of Guam; now therefore, be it

9 Guam; and be it further


10           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
