1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2        ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***

1           **WHEREAS**, the Domino Lux International (DLX) Fraternity and Sorority was  
2 established on September 20, 1974, at De La Salle University in the Republic of the  
3 Philippines, by fourteen extraordinary men who believed in extending the camaraderie  
4 of brotherhood and family not only beyond college but also throughout their lives; and

5           **WHEREAS**, the membership of DLX is comprised of dedicated men and  
6 women who have taken the pledge to continue carrying on the DLX core values of  
7 brotherhood and sisterhood, and the intellectual, cultural, physical and spiritual  
8 welfare of its members. Communities across the globe continue to benefit from the  
9 numerous civic contributions of DLX, as worldwide members continue to carry on a  
10 tradition of goodwill and public service to their respective communities; and

11           **WHEREAS**, through the promotion of strength and foundation of family as the  
12 core to a successful and fruitful life, the men and women of DLX have been able to  
13 further realize their personal and professional endeavors; and

14           **WHEREAS**, the Domino Lux Fraternity's guiding principles center on the  
15 following goals: (1) to promote the spirit of camaraderie among the members; (2) to  
16 inculcate in every member the value of scholarship, and act as a guiding force in the  
17 pursuit of chosen careers, and making every member fully prepared for his or her  
18 current and future state; (3) to improve the social attitudes and conduct of each  
19 member; (4) to provide a medium in developing and polishing the potential in every  
20 member; (5) to develop the physical and mental well-being of each member; and (6)  
21 to uplift spiritual awareness in every member to achieve a well-rounded personality;

23           **WHEREAS**, on June 18, 2008, the Domino Lux International Fraternity, Guam  
24 Chapter, was informally established with eighteen original founding chapter members,  
25 and it currently has more than nine hundred members. The Domino Lux International

1 Sorority opened its doors on Guam in 2012, and it started with Lorna Francisco,  
2 Jennifer Aguon, Rosette Pasetes, Neline Cruz, Angustia Flores and Tia Flores; and  
3 they quickly grew to have numerous other sorority sisters. In August 2012, Domino  
4 Lux International established the Guam International Boxing Council (GBIC), which  
5 has taken Guam by storm in promoting amateur boxing and kickboxing; and


6 **WHEREAS**, on June 21, 2014, the people of Guam will further witness the  
7 outstanding dedication that Domino Lux has for our island community. The “2014  
8 Domino Lux Peace Festival” will host an array of events to further bolster peace and  
9 prosperity in Guam and around the world; and to celebrate the month of June as the  
10 founding month of DLX international. The DLX Annual Red Carpet Ball will also  
11 take place in celebration of the organization’s founding day; and


12 **WHEREAS**, the men and women of the Domino Lux International Fraternity  
13 and Sorority continue to stand out as elite members of our community as they give of  
14 their time and dedication to help those in need, and further commit themselves to  
15 improving the quality of life for the people of Guam and around the world; now  
16 therefore, be it

18 *Lihe slaturan Guåhan* does hereby, on behalf of *I Lihe slaturan Guåhan* and the people
