3 **WHEREAS**, education and sports have always been a major part of the life of
4 Loring Santos Cruz; and

5 **WHEREAS**, in 1973, Loring Santos Cruz received his high school diploma
6 from George Washington High School. He then attained a Bachelor of Arts degree in

1 Secondary Education/Social Science, with a minor in Physical Education, from the
2 University of Guam; and he attended post graduate studies at both the University of
3 Guam and the University of Hawaii; and

4 **WHEREAS**, from 1977 to June 2014, Loring Santos Cruz dedicated his life to
5 working as a Physical Education Teacher at George Washington High School, where
6 he would touch the lives of thousands of students, faculty, and staff for thirty-six (36)
7 years; and

8 **WHEREAS**, Loring’s contributions as an educator did not stop in the
9 classroom, but extended on to the football fields and track & field facilities, as he
10 became one of Guam’s finest track & field coaches and a legendary football coach;
11 and

12 **WHEREAS**, Loring Santos Cruz has impacted and influenced many athletes
13 who are now in positions of leadership in the sports community; and

14 **WHEREAS**, Loring Santos Cruz’ dedication as a coach extends almost forty
15 (40) years; and during this time, he has coached and mentored thousands of students
16 and athletes; and

17 **WHEREAS**, Loring’s extensive sports involvement as a coach began in 1976,
18 when he served as an Assistant and Head Coach for the George Washington High
19 School football and track & field teams; and he was also the Defensive Coach for the
20 University of Guam Tritons; and the Head Coach for the Pepsi Giants; and

21 **WHEREAS**, during his coaching tenure, Loring Santos Cruz would coach
22 many of his teams to win numerous Interscholastic Football League and Miller
23 Football League championships; and


24 **WHEREAS**, Loring Santos Cruz was in multiple editions of “Who’s Who
25 Among America’s Teachers” - honored and published: 4th Edition 1998; 6th Edition
26 2000; 7th Edition 2001; and 8th Edition 2002; and

1 **WHEREAS**, Loring Santos Cruz has left his “fingerprints” on the hearts and
2 lives of his students and athletes in his career as a coach and educator; now therefore,
3 be it


4 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
