1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÁHAN*:**

3 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona, former Mayor
4 of Rota, Commonwealth of the Northern Mariana Islands (CNMI), was born on May
5 27, 1934; and he passed away on May 3, 2014, at the age of eighty (80); and

1 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona was a devoted
2 and loving husband to †Bernadita Atalig Manglona; and was an exemplary father and
3 grandfather to his children and grandchildren; and

4 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona began his
5 career in public service working as the Marianas District Administrator Representative
6 during the U.S. Trust Territory period - from 1956 to 1974 ; and

7 **WHEREAS**, from 1974 to 1977, the late Honorable Prudencio Taisacan
8 Manglona served as the Resident Commissioner’s Representative; and he then served
9 as the Mayor of Rota, CNMI, for sixteen (16) years - from 1978 to 1994; and

10 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona was very
11 instrumental in the increase of the number of tourists to visit Rota, as well as in the
12 improvements of the prime tourist destinations on the island, and throughout the
13 Commonwealth of the Northern Mariana Islands (CNMI); and

14 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona was a
15 productive and respected leader, who was one of the Founding Fathers of the
16 Commonwealth of the Northern Mariana Islands (CNMI) Constitution; and


17 **WHEREAS**, on the day of his eightieth (80th) birthday, which was celebrated
18 on May 27, 2014, the late Honorable Prudencio Taisacan Manglona received a
19 Commemorative Resolution from the CNMI Senators recognizing him for his
20 “exemplary, innovative and progressive leadership in public service, community
21 building, and economic development”; and

22 **WHEREAS**, the late Honorable Prudencio Taisacan Manglona was a man of
23 compassion and honor, and whose passing will leave a void that will be felt for many
24 years to come, in both the family he loved and the island he so proudly served; now
25 therefore, be it


1 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
2 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
3 of Guam, recognize and honor the late Honorable Prudencio Taisacan Manglona,
4 former Mayor of Rota, Commonwealth of the Northern Mariana Islands, for his many
5 accomplishments, and his dedicated service and invaluable contributions to the people
6 of his home island of Rota, CNMI; and does further extend sincere and humble
7 condolences on his passing to his family, friends, and the people of Rota, CNMI, who
8 he represented with great pride and dedication; and be it further

9 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
10 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
11 the same be thereafter transmitted to the family of the late Honorable Prudencio
